Oak Glen receives donation to expand its media center

NEW MANCHESTER — A donation from an Oak Glen High School alumnus is being touted as the essential ingredient for a refurbished and expanded school library.

More than a library, the Chaffin Luhana Foundation Media Center will combine traditional library resources with modern communications

technology, school officials said on Wednesday. "This center is going to be the center for every student to come in and to really become college- and career-ready," OGHS Principal David Smith said.

The \$25,000 grant from the Weirton-based Chaffin Luhana Foundation, founded by law partners Eric Chaffin and Roopal Luhana, will be used to remodel Oak Glen's old library space and outfit

Mayor expresses frustration over grass cutting issue

WELLSVILLE — Wellsville Mayor Susan Haugh is tired of dealing with some residents not cutting their grass.

Haugh expressed her frustration with the grass cutting issue during Tuesday's council meeting after a resident inquired during the public comments portion about the village's grass ordinance, which is a six-inch height limit, and whether or not the village will mow certain lawns. Haugh originally planned to discuss the matter later during the Mayor's Report, but after the grass ordinance inquiry was brought up, she decided then to provide comment.

"There are a few of us doing a whole lot of work," Haugh said. "A lot of good things are going on in Wellsville, and it irritates me to no end to have to stop what I'm doing, or Thom (Edgell,

village administrator) stop what he's doing, to tell a grown adult that they need to cut their grass."

The mayor explained to the guests that she was on Broadway Avenue earlier in the day and was scolded by a resident for another resident's grass being too high.

City man accused of sexual related crimes indicted by grand jury

LISBON — A man accused of several sexual related crimes with a 7-year-old child was among indictments issued this week by the Columbiana County Common Pleas Court grand jury.

Erwin E. Brown, 37, Columbiana County Jail, Lisbon, formerly of Green Lane, East Liverpool, is charged with two counts of kidnapping with a specification of sexual motivation. He is also charged with attempted rape with the specifications that if the rape had been completed, it would have been with a child younger than 10 and after Brown already had been convicted of a sexual offense in 2001.

Additionally he is charged with gross sexual imposition

BDD board approves changes

LISBON — The changes coming in direct services for clients served by the Columbiana County Board of Developmental Disabilities were approved by the board Wednesday.

By the end of 2015, Employment Development Inc. will be responsible for operating

EDI-South in Calcutta. Additionally, the board approved a similar transition at EDI-Central with Employment Development Inc. taking over all the direct services in the county by Dec. 31, 2018.

The Conflict Free Case Management mandate by the federal government demands that all of

Ohio's BDDs cease providing direct services to clients themselves in the near future. County BDDs currently both develop the plans to assist those with developmental disabilities and provide them with those services. It has been determined that doing both is a conflict of interest.

CCCTC to receive upgrades this summer

LISBON — The cosmetology classrooms and corridors at the Columbiana County Career and Technical Center will receive an upgrade this summer after the board approved contracts for the renovations.

The board approved the general trades contract to J.

Herbert Construction Co. in the amount of \$371,100. Additionally, the plumbing contract was awarded to JP Plumbing for \$40,900; the HVAC contract to York Mahoning for \$107,900 and the electrical contract to Graft Electric for \$214,286.

Superintendent Chuck Adkins said the reason the electrical contract was so high was due to the amount

of electrical work needed to refit the corridors with new LED lights. Additionally, he said the cosmetology lab also needs a large amount of electrical work. The hallway work will also include ceiling tiles.

Overall he said they were pleased with the bids, which came in substantially less than what the architects predicted.

In other matters:

— The board approved the retirement resignations of Donna Moser, school nurse; and David Kaszmarek, the culinary careers instructor. Adkins pointed out Moser has 28 years of "very dedicate" time on the job. Kaszmarek helped open the CCCTC in 1977, according to Adkins, and has about 44 years in teaching.

Board President Mark Hudson also chimed in about how he was sorry to see the both of the retirees go.

"The guy's a gem," Hudson said. "He's a class act and he always has been."

Board member Gary Peruchetti pointed out he was at a recent event catered by the CCCTC, and Kaszmarek made his way through the crowd, personally talking to everyone there. It was also noted the students look up to him.

— The board decided not to replace Carol Henrich, a long time secretary, who retired a few months ago. They decided to reduce that position and also Kaszmarek's position. JR Straley, who was hired into culinary careers a couple years ago in anticipation of Kaszmarek's retirement will now take over the program completely.

— The board approved hiring Carolyn McCune as the LPN Adult Education Coordinator for next school year.

— The board also approved three-year contracts with one percent base salary raises each year, insurance rates remaining the same for many of the CCCTC employees including those in the central office and the administration.

— Tuesday after the board meeting was the senior awards ceremony for high school graduates at the CCCTC. Next Wednesday at 6 p.m. will be an adult education spring graduation ceremony. The next meeting of the board will be at 7 p.m., June 16.

and unlawful sexual conduct with a minor.

On April 28, Brown allegedly convinced an older boy to help him lure a 7-year-old boy and then transported three boys to Jefferson County with the purpose of getting the 7-year-old to engage in sexual activity with him. According to police reports at the time, the 7-year-old refused to cooperate and instead "kicked the guy in his bad area." Those alleged activities are the majority of the charges against Brown. The additional kidnapping charge and unlawful sexual conduct with a minor charge involve a teenager, at least 13 but less than 16. According to the indictment, Brown allegedly sometime during the spring months of 2015 also took this teenager to Jefferson County for the purpose of engaging in sexual activities with Brown.

The grand jury issued a total of 10 open indictments after hearing 27 cases. Another 14 secret indictments were issued, while the grand jury chose not to indict in three of the cases. The secret indictments will be released as they are served to the defendants.

Superintendent Bill Devon said the BDD is going to look a lot different in the future, focusing instead on oversight of the services being provided to clients. He noted right now they will focus on making as "seamless" a transition as possible for the clients they are serving.

Devon provided a map showing the privatization status of different counties in Ohio as of February 2015. Of the state's 88 counties 20 were privatized at that time and another 20, including Columbiana County were discussing making changes. Columbiana County will now join five other counties listed as in the process of making changes. Some have not begun, but Devon said the transition must be completed by St. Patrick's Day 2019.

"I really think the state of Ohio (already) has the best system in the world for helping people with disabilities," Devon said, adding while he may be saying too much, he finds it discouraging the federal government feels they need to step in and change it.

Devon said throughout the transition process, he wants to encourage anyone with questions about the changes to contact him either by stopping by his office, calling 424-7788 or emailing him at bdevonccbmrdd@spii.net.

In other matters before the board:

— Although it was hot, about 90 degrees on May 9, the first Best Buddies Walk at the Lisbon High School Track was touted as a success. The board learned the event raised \$7,317, more than the \$5,000 goal. About 124 people walked during that morning and event helped put the Best Buddies organization about 50 percent of the way toward its financial goal needed to start an Ohio chapter. Board members discussed making a few changes, but having the event again next year if they are asked. Columbiana County Board of Developmental Disability is reportedly the first county board in Ohio to host a friendship walk.

— Robert Bycroft graduation will be held at 6 p.m., May 28.

— About 350 attended the Spring Dance this year at St. Jude's Church in Columbiana, which was catered by The Georgetown.

— The board does not plan to meet in July.

it with new furniture, approximately 800 new books, a mobile lab and wireless infrastructure, Smith said.

The library has been mostly unused since the retirement of longtime school librarian/media specialist Larry Shaw in 2012. At the start of the current school year, Oak Glen officials removed most of the books, putting some in storage, and began working on a plan to adapt the space for reuse as a modern media and broadcast center.

Critical to that effort, Smith said, was the hiring of English teacher Lissa Dulick and Assistant Principal Carla Carinci-Bell. Dulick has been using the area as a classroom and foresees big changes in the coming school year.

"This incredibly generous donation will enable us to provide facilities and resources to enhance the already skilled and talented teaching that takes place here every day," she said.

In addition to Dulick, Smith and Carinci-Bell, other members of the Oak Glen media team are social studies teacher Ted Arneault, English teacher Morgan (Martin) Bricker and math and technology teacher Julie Zoellers.

At a news conference on Wednesday, the media team members unveiled their concept for the media center. They described it as a "hub of the building where students and faculty can go to read, write, study, create projects, communicate and collaborate."

Arneault defined it as a "modern resource area for evidence-based learning. ... We have to expand our classroom beyond the classroom."

The center will include a circulation desk, a reading corner, bookshelves, a "collaboration area," broadcasting equipment and classroom seating. There, students will be able to do research, work as teams and improve their communication and problem-solving skills, Smith said.

"It really puts us on the path to be ahead of every curve in West Virginia," he said.

Smith said the \$25,000 gift, plus \$5,000 raised by the school, will pay for all of Phase 1 of the media center, which will open in August, and parts of Phase 2. Phase 1 includes remodeling (new flooring, design and furniture), updated database subscriptions, new acquisitions for the fiction, nonfiction and reference sections, community outreach activities, staff development and student training in media center policies, resources and database usage.

Chaffin, a 1989 graduate of Oak Glen, used Wednesday's press conference to reflect on his own education and his "blue collar" upbringing. Now a plaintiffs lawyer in New York City, Chaffin said he was the first person in his family to go to college.

"When I came here to Oak Glen, I wasn't that engaged. ... I knew that I wanted to do things in life, but I didn't really know how to do them or how to access information," he said.

Chaffin said a professor took one look at his high school grades and gently suggested that college was not for him.

Chaffin said it was a "no-brainer" to contribute to the media center effort.

"Research and communication skills are key to our law firm's success. Access to information is critically important," he said. "We see the value in teaching students these skills early, and that can happen only if they have access to appropriate materials."

In addition to expanding the media center, Oak Glen is redesigning its journalism course descriptions and curricula, Bricker said.

Journalism I will cover such topics as the First Amendment (journalism law and ethics), news literacy/newsworthiness, interviewing and information gathering, news writing, feature writing, alternative story forms, photojournalism and publication design.
